1. APPLICATION OF THE PRIVACY NOTICE

The MOTIQUE Group Limited (collectively referred to as "we", "us", "MOTIQUE" or "the Company") Privacy Notice applies to the Personal Information of visitors and investors who visit our Corporate MOTIQUE Website and who engage with us in any manner ("you").

2. WHAT PERSONAL INFORMATION DO WE COLLECT AND PROCESS?

We respect your privacy and we will comply with all applicable laws when handling your Personal Information. In this Privacy Notice, Personal Information is used as defined in the Protection of Personal Information Act 4 of 2013 (POPIA). Personal Information is largely any information that is used to identify a juristic person or a natural person.

When you use our Website we may collect, without detracting from the generality thereof, the following Personal Information which belongs to you:

- Your input data such as your name, email address; including password or identifiers, which may have been allocated to you as part of the registration for alerts on the Vault alert services on the Website; when making enquiries or interacting with us about our services via any electronic platform such as email.
- Metrics and information collected by Google analytics which may include device identification; network and connection information (including Internet Service Provider (ISP) and Internet Protocol (IP) addresses), device and browser identifiers and information, cookie identifiers and information, and similar data as applicable; usage information and browsing history, such as usage metrics, content interactions (including searches, views, downloads) and user journey history and approximate geographical location. 3.1 The Personal Information which you provide to us is used for the following purposes:
- to register for alerts and Securities Exchange News Service (Sens) announcements on the Vault platform; to provide any information to you that you have requested; to enable access to the corporate intranet; to provide you with any Company information, goods or services that you have enquired about and/or requested; to provide, maintain, protect and improve our Website; to manage our relationship with you (for example, customer services and support activities); to deliver services with third parties with whom you have a separate relationship; to monitor, measure, improve and protect our content, Website offerings and provide an enhanced user experience;
